NON-EXCLUSIVE LICENCE AGREEMENT

Article 1
The subject matter of this agreement is:
a) author, title, place and date of issue

Article 2

- 1. The Licensor represents that this work does not violate any rights of third parties. The work has been prepared with respect for the copyrights of other authors.
- 2. The Licensor represents that it has copyright in the scope covered by this agreement. Use of the work by the Licensee shall not violate the rights of third parties.

Article 3

- 1. The Licensor grants the Licensee a licence to use the work specified in Article 1.
- 2. The Licensor grants the Licensee permission to record and reproduce by uploading the work into the memory of a publicly accessible computer on the premises of the Main Library of the Medical University of Gdańsk.
- 3. The Licensor grants / does not grant* the Licensee permission to distribute the work in such a way that anyone can access it from a place and at a time of their choice (online).

Article 4

The licence is free of charge.

Article 5

- 1. The agreement is concluded for indefinite time.
- 2. The Licensor may terminate the agreement upon giving a two months' notice.

Article 6

The Licensor consents to a change of the document format in which the work was originally recorded, without changing its content, to the extent justified by the use of the work under this licence.

Article 11

Any disputes arising in connection with performing this agreement shall be settled by the court having jurisdiction over the Licensee.
